TH#1-8 are similar but vary to rock refusal (TH#1,2,6,7 are 12' deep TH#4 is 5' TH#5 is 6' TH#3 is 9' and TH#8 is 8' deep) 0-1' topsoil 1-8' 70% rock with scl in matrix evidence of mottling present throughout indicating seasonal saturation

- " Surface characterization method described in ASTM D5879-95 (reapproved 2003) has been used to determine the existence of the following surface limitations: washes to the east and west
- " Subsurface characterization method described in ASTM D5921-96 (reapproved 2003) has been used to determine the existence of the following subsurface limitations within 12 feet of grade: 5-12' deep test holes
- " The soil absorption rate determined under A.A.C. R18-9-A312(D)(2) is: .40

Build system inside 30' radius of discovery holes and in accordance with applicable rules. Maintain 100' from all wells, 50' from washes draining greater than 20 acres and undeveloped property lines.


